1.	Candidates who applied and get selected may be posted at any work center within ONGC, Ahmedabad.
2.	Engagement is purely temporary on contract basis. Duration of contract is for two years i.e. from 01.07.2018 to 30.06.2020 . Contract tenure will commence from the date of joining. Selected candidates will have to sign a contract with ONGC for the above engagement as per the terms and conditions of ONGC.
3.	Selected candidates will be paid consolidated monthly remuneration as mentioned above (no other allowances will be admissible).
4.	 i) In-house OPD facility where ONGC hospitals / dispensaries exist in respect of self, spouse & two immediate Dependents i.e. children and/or parents. However, outside reference for medicine / consultation shall not be permissible. ii) Family floater cover of ₹5 lakhs for indoor treatment in respect of self, spouse & two immediate dependents i.e. Children and/or parents.


