SUB: Guidelines for Engagement of Domain Experts for OEC

ONGC Energy Centre (OEC) has been set up by ONGC with the objective of making an impact on the nation's energy scene by developing marketable solutions in the field of alternate energy. The Centre is run by the OEC Trust, which is chaired by CMD, ONGC.

OEC has launched research projects in several new and alternative sources of energy, through In-house research as well as in collaboration with various leading academic and research Institutes and some of the International agencies. These Projects are in various stages of development, and have potential as far as sustainable energy solutions are concerned. In order to seek expert advice to manage and coordinate the technical activities in some of the projects, ONGC Energy Centre (OEC) has decided to engage specialists as Domain Experts. The following guidelines have been evolved for engagement of the Domain Experts by OEC:-

1.0 Eligibility Criteria

Experience

- 1.1 Any Expert with at least 25 years of overall experience and preferably 10 years of experience in the relevant field will be eligible to be considered. (At the time of inviting applications for engagement of 'Domain Expert' on Contract Basis, the Scope of Work, specific deliverables, and milestones to be achieved during the period of contract engagement will be specified. This will become a part of the eligibility criterion.)
- 1.2 The following category of Experts, with above requisite experience and expertise shall be considered for this purpose:
 - Former employees of ONGC/Group companies who have served at E6 and above Levels.

- ii. Teaching & Non-Teaching Technical Experts from Institutions of higher education like IIT/ IIM/ IISC/ Central Universities/National Labs/other reputed institutes in that particular field etc.
- iii. Scientists/Research Officers in Central/State Government, PSUs and other research institutions/organizations of repute, in the pay scale equivalent to CTC for E6 and above Level Employees of ONGC.
- iv. Suitable Experts with requisite experience and expertise from Private industry.

2.0 Tenure of Engagement

'Domain Experts' may be engaged initially for a period up-to one year. However, if the requirement for Domain Expert in any particular activity continues for a longer duration and the performance of the individual, who has been engaged as 'Domain Expert' is found satisfactory, his/her tenure may be extended on need basis, by another 6 months or one year, as the case may be. However, the total duration of engagement of an Expert as 'Domain Expert' shall be limited to a maximum of three years.

Besides this, they shall also be entitled to-

TA/DA and traveling facilities, outside accommodation on official tours, as admissible to E-6 and above level executives of ONGC (This will be specified/ decided on case to case basis, depending upon the experience and the level of previous/last position held by the Candidate).

 Addl. Consolidated Monthly Pay of Rs.10,000/- may be considered for executives who have held E9 & above or equivalent posts in ONGC or equivalent PSUs.
