3. Broad Roles and Responsibilities of the Post:

- a. Overseeing functions of Maintenance & Safety aspects of chartered helicopters.
- b. Analyzing of incidences for corrective measures.
- c. DGCA clearances of helidecks at offshore.
- d. Planning & execution of Technical & Safety Audit of Operators and their chartered helicopters and also subsequent compliance audits.
- e. Liasioning with helicopter operators for early compliance of Audit observations for enhanced Safety.
- f. Preparation of ATRs on various Aviation Safety issues/ matters raised by Collectives to DGCA and ONGC authorities.

4. **SELECTION PROCESS:**

Selection will be on the basis of educational qualification, experience and performance in personal interview. In case the number of candidates who apply and fulfil the eligibility criteria are more, the Appointing authority shall decide the number of candidates to be considered for the post and may accordingly enhance the criteria for Qualification and / or experience.

Final Selection: Only such candidates will be considered for empanelment in the merit list who meets the prescribed Qualification and Experience criteria and secure minimum 60% of marks in interview.

5. Finalization of Merit List

- **a.** Offer of appointment shall be issued to the candidates based on their relative rank in the Merit List prepared on the sum total of marks scored by the candidate in Qualification, Experience and Interview.
- **b.** In case of a tie in the total marks scored between two candidates, candidate who has performed better in interview is considered senior in the merit list.
- **c.** In case the total marks and interview marks both are equal between two candidates, the candidate who is older in age is considered senior in merit list.
- **d.** Departmental candidates will be given first consideration in matters of selection, while other things such as qualification, eligibility and selection criteria etc. remain the same.

e. Appointment of selected candidates will be subject to their passing the company's Medical Examination as per standards laid down under ONGC Medical Examination of Employees Rules, 1996. Details of the rules are available on ONGC's Website at www.ongcindia.com.

6. How to Apply:

- **b.** Candidates will be informed about mode of interview i.e. to appear in-person or through online method with details of date, time and venue etc. In case it is decided to conduct interview through online method, the candidate should be able to connect through Microsoft Teams, Google Meet/Zoom/WhatsApp, Webex etc. as the case may be.

- **f.** In case of a face to face interview, candidates will be required to bring the above documents in original along with a set of Self-Attested Photocopies of documents and report as per date, time and venue intimated.

8. General Instructions:
